

NATIONAL MOOT COURT COMPETITION



(CRIMINAL LAW)

ELIGIBILITY

- 1. The Competition is open to bona fide undergraduate students of recognized Colleges/Institutions/Universities who are currently pursuing their Bachelor's Degree in Law i.e. 3 years LLB or 5-year Integrated or Honors' LL.B Program with all combinations on a regular basis.
- 2. A maximum of two teams from one law college can participate but no student must be repeated.

TEAM COMPOSITION

- 1. Each team shall comprise of a maximum of 3 members and a minimum of 2 members consisting of either 2 speakers and 1 researcher or 2 speakers only. The number cannot be modified under any circumstances.
- 2. No extra member/faculty/observer shall be allowed.
- 3. Also, no deviation from the chosen names shall be allowed.
- 4. Cross University teams are not allowed in the competition. This means that the team members must be from the same University.

STRUCTURE OF THE COMPETITION

The competition will have four rounds-

- Preliminary Round Semi-Final Round Final Round
- 1. The Competition will have a Researcher's test on the first day.
- 2. Memorial from each round is to be submitted in hard copy according to the given guidelines.
- **3. NOTE-**Details of each round, the Researcher's test, and the guidelines for Memorial submission are mentioned in the link given below. Please refer.
- 4. The official working language of the National Moot Court Competition, 2023 shall be English.

CRIME SCENE INVESTIGATION



COMPETITION

ELIGIBILITY

- 1. The Competition is open to bona fide undergraduate students of recognized Colleges/Institutions/Universities who are currently pursuing their Bachelor's Degree in Law i.e. 3 years LLB or 5-year Integrated or Honors' LL.B Program with all combinations on a regular basis.
- 2. A maximum of two teams from one law college can participate but no student must be repeated.

TEAM COMPOSITION

- 1. Each team shall comprise of a maximum of 2 members. The number cannot be modified under any circumstances.
- 2. No extra member/faculty/observer shall be allowed.
- 3. Also, no deviation from the chosen names shall be allowed.
- 4. Cross University teams are not allowed in the competition. This means that the team members must be from the same University.

FORMAT OF THE EVENT

- 1. A crime scene investigation competition is typically organized to assess participants' skills in forensic analysis, critical thinking, problem-solving, and teamwork.
- 2. Each team will be given a total of 15-20 minutes to visit the mock crime scene (or view provided images/videos) to examine and document the evidence.
- 3. They will need to collect evidence (photos), take notes, and make sketches.
- 4. Report writing- After the investigation, the participants will have a limited amount of time to write a report about their findings.
- 5. Teams or individuals present their findings and conclusions to a panel of judges. Judges will evaluate the quality of the investigation, the accuracy of the analysis, the coherence of the conclusions, and the clarity of the presentation.

THEME OF THE COMPETITION

The theme of the competition will be set around a criminal activity conducted in a naturalistic setting where students have to identify what happened and how it happened.

- 2. The Registration Fee is **INR 2500** /- which shall be payable through Online Transaction Mode and shall be made in favor of Shoolini University.
